- c. Update on Lt. assessment process. Assistant Chief Jensen advised the Commission that Division Chief Coleman is putting together a training program in-house to hopefully promote from within to take place in the Spring of 2021.

a. Report on Firefighter assessment process to fill current and future position vacancies. Assistant Chief Jensen provided a brief statement to the Commission regarding the 2 vacancies, one due to the promotion of Nick Ryan to Captain and due to one of our EMT Firefighters giving notice and moving back to where his family is from. The process is in the application stage right now closing mid-April then the testing will begin. Once the testing is complete then if candidates are chosen they would start at Mid-Columbia Fire and Rescue mid-July.
