12. NEW BUSINESS

- a. Resolution 2024-5 Director Case made a motion to adopt Resolution 2024-05, a Resolution authorizing the Fire Chief to execute an intergovernmental agreement between Mid-Columbia Fire and Rescue and Wasco County concerning distribution and use of grant funds awarded to Wasco County for a Community Wildlife Defense Grant Project. Director Schaffeld seconded. Motion carried with 4 Ayes, 0 Nays.
- Information Sheet Surplus Property. Director Case made a motion to declare items on Exhibit "A" as surplus. Director Shaffeld seconded. Motion passed with 4 Ayes, 0 Nays.
- c. Fire Chief's Contract The Fire Chief's contract was thoroughly discussed, with proposed edits. Director Bailey requested these edits be reviewed before approval, while Director Case wanted to delay approval until after the background check. The draft contract will be considered for ratification at the November Board meeting.

President Jacobs called for a motion on the salary. Director Schaffeld moved to set the salary at Step 3 starting December 1st, 2024, for the chief's position, seconded by Director Case. The vote passed unanimously with 4 Ayes, 0 Nays.

Director Bailey stated that the salary will take effect only if Chief Jensen passes the background check and the Board signs the contract. The motion solely addressed the salary, and the vote was unanimous.
